COMMUNITY HEALTH ASSESSMENT

Local health departments are required to conduct a community health assessment (CHA) every five years. The goal of the CHA is to collect, review, and analyze health data in the community. This report helps us understand the health status of our community and the factors that impact health. In 2017, CRCHD and partner agencies met to discuss the CHA process, develop survey questions for the CHA, and identify other possible data sources and methods. Essential to the CHA was the input of many community sectors to provide various perspectives in the determination of assets, resources and health challenges. Primary data for the CHA came from an anonymous resident survey and a key-informant survey, both funded by Ascension, Aurora Health Care, and Children's Hospital of Wisconsin. Additional data came from a CRCHD Partner Survey. Lastly, many data elements were derived from

local, state and national sources. Using these data, a preliminary CHA was developed. Findings from the CHA can be found at www.crchd.com. The CHA findings will be used to develop a Community Health Improvement Plan (CHIP). The goal of the CHIP is to take information gathered in the CHA—combined with input from community members, Board of Health, and governmental, business and community agency stakeholders—and translate it into a meaningful vision and roadmap to improve our community's health together. CRCHD utilizes the Mobilizing for Action through Planning and Partnerships (MAPP) framework to isolate and collect data, determine health issues, and identify existing assets and resources. The framework is a community-driven strategic planning process for improving community health.

- Remember to clean your hands with soap and warm water before handling the food, after handling the food and before eating the food.
- Clean surfaces before and after preparing food on them.
- Separate raw meats and seafood from ready-to-eat foods.
- Use a food thermometer to make sure foods are cooked to a safe internal temperature.

Internal Temperatures

- Ground beef and sausages 155°F
- Seafood 145°F
- Roasts/Steaks/Chops 145°F
- Hold all hot food at 135°F

A New Community-Wide Home Visiting Program

Family Connects Racine County is a community-wide nurse home visiting program that uses an evidence-based model, structured with a universal approach. Program services are for all parents of newborns in Racine County and visits are tailored to meet families' needs. Our mission is to enhance family and child well-being. Research shows that every family has needs around the birth of a child. Family Connects provides between one and three nurse home visits to families with a newborn beginning at about three weeks of age, regardless of income or demographics. Nurse visitors offer supportive guidance, respond to family questions about newborn care, and help bridge the gap between parent needs and community resources. Participation is voluntary and at no charge, and open to all Racine County families who have just given birth. Radon Testing

You can't see it, smell it or taste it, but radon may be a problem in your home. Radon is a naturally occurring. radioactive gas that may be present in the soil beneath your home and can build up to dangerous levels inside any home. Long term exposure to radon gas can cause lung cancer. Only smoking causes more lung cancer deaths. Testing is the only way to know if you and your family are at risk from radon. Testing is inexpensive and easy. If your house has a radon problem, it can be fixed. Radon test kits are available for \$7 at CRCHD or, to find the closest municipality with radon test kits, call 262-898-4460.

Cribs for Kids

CRCHD is an official Cribs for Kids partner agency and conducts safe sleep education in the community. Parents and caregivers can reduce the risk of sleep-related deaths by following some simple guidelines to improve the sleep environment for their infant. The safest way for your baby to sleep is to follow the ABCs of safe sleep:

Alone, on his/her Back, in a Crib free of loose and soft bedding such as pillows, comforters, bumpers or stuffed animals.

Free Car Seat Inspections

Child safety seats can reduce the risk of a potential fatal injury. The American Academy of Pediatrics recommends that infants and toddlers should ride in a rear facing safety seat until they are 2 years of age or until they reach the highest weight or height allowed by their car seat manufacturer. Child safety seats must be installed correctly and used properly to be effective. While 96% of parents and caregivers believe their seats are installed correctly, research shows that 7 out of 10 children are improperly restrained.
