

Strategic Plan

In 2023, RCPH gathered data and feedback from employees and community partners to determine the department's goals for the next 5 years. RCPH provides community education using novel and existing technologies with a focus on regular messaging. In 2023, RCPH shared



RCPH provides leadership to drive the development of public health plans and policies that are consistent throughout the state but that address local needs.






Public Health Policies and Laws

RCPH regularly develops and updates policies and procedures for internal use as well as develops, promotes, and educates elected officials regarding local and state policies and laws. In 2023, RCPH had an MOU with Kenosha County to provide public health legal authority during a time of transition.

State and National Public Health Accreditation

In 2023 RCPH completed the PHAB Year 3 report. and continued to follow the PHAB guidelines to stay on track for reaccreditation in 2025.

Performance Management & Quality Improvement Plans

In 2023, RCPH continued to refine its PM/QI processes. The Healthy Families Racine County team worked on family engagement and enrollment. The Racine County Spike Alert protocol was also tested and a new protocol for data surveillance was put into place to improve communications and clarify sustained increases of suspected opioid overdoses in the county.







Outbreak Investigations

RCPH investigated 32 outbreaks in long term care facilities in 2023.

Clinic Services

In 2023, the RCPH clinic provided:

- 128 pediatric vaccines to 28 pediatric clients (includes 20 influenza vaccines and 5 COVID-19 vaccines)
- 17 adult vaccines to 11 adult clients (includes 4 influenza vaccines and 6 COVID-19 vaccines)
- 11 TB skin tests

Population-Based Immunization Compliance Program

RCPH monitors population-based immunization rates routinely by generating letters to the parents of children approaching the age of two who may be behind on their immunizations.



School and Daycare Immunization Compliance Program


RCPH conducts surveillance, analysis, and assurance of vaccine completion rates for licensed daycare centers and schools. In 2023, RCPH worked with 32 daycares and 38 schools to complete immunization reporting.





Fetal, Infant, & Child Death Review


The now hybrid FICDR team works to ensure accurate identification and uniform reporting of the cause, manner and relevant circumstances of every fetal, infant and child death. The goal is to identify preventable causes of death and inform program and policy direction in the community based on team findings and trend analyses. 51 cases were reviewed in 2023.





Overdose Fatality Review


In 2023, RCPH introduced a new protocol to respond to increases in suspected opioid overdose rates in Racine County. RCPH monitored overdose data daily and The Racine County Overdose Fatality Review Team issued "Spike Alerts" once an increase was identified. Racine County had record high rates of overdose and the new protocol allowed for more timely and specific response.

Fentanyl Awareness Campaign

In 2023, RCPH helped to launch a fentanyl awareness public service announcement. The campaign started on May 9, 2023 which is Fentanyl Awareness Day and ran throughout spring and summer. Channels included GSTV, Hulu/Disney, Spotify, Marcus Theaters, Facebook/Instagram, Valpak, and Lamar billboards.

<u>Man Therapy</u>

In 2023, RCPH introduced Man Therapy, a 24/7 online platform that uses humor and story telling to break down stigma around mental health care for working age men.

In Racine County between January 1 - October 3, 2023:

- 469% increase in total users in Racine Co
- 283% increase in completed head inspections
- 27 total crisis line engagements





Lead Poisoning Case Management <u>& Lead Hazard Assessments</u>

Health department staff certified as Lead Hazard Investigators provide home assessments to determine potential source(s) of lead contamination and discuss possible solutions for remediation.







HUD Lead Marketing Campaign

RCPH, in partnership with Kenosha County Health Department and the City of Racine Public Health Department, launched a marketing campaign for the Live Lead Safe program.

5/30/23 - 12/31/23

- 24 referrals via online eligibility form
- Marketing to 43 libraries, medical offices, municipalities, businesses and schools
- 1000+ marketing pieces, both hardcopy and digital

Radon Testing

In 2023, RCPH sold 24 short term/8 long term radon test kits. Of the short term purchased, 88% were sent by the homeowner for analysis; 67% of kits analyzed had a result greater than or equal to 4.0 pCi/l (recommended remediation level).



<u>Human Health Hazards</u>

"Human health hazard" means a substance, activity, or condition that is known to have the potential to cause acute or chronic illness, to endanger life, to generate or spread infectious diseases, or to otherwise injuriously affect the health of the public.





Environmental Health Licensing and Inspections

Environmental health staff provided licenses and inspections to the listed establishments.

Additionally, RCPH continued to provide mutual aid to the City of Racine Public Health Department by completing 36 inspections.

The RCPH Food Safety Training video was viewed 37 times in 2023. 22 certificates were mailed to individuals who completed the training and quiz.



Rabies Exposure Investigations

RCPH continues to investigate potential rabies exposures to ensure the animal is not rabid and the victim has not been exposed to rabies. Each rabies exposure investigations requires a large amount of time to complete. In 2023, RCPH conducted 147 rabies exposure investigations.



DNR Well Water Program

In 2023, RCPH tested 145 wells, performed 114 annual site assessments, and completed 31 sanitary surveys.



Well Water Testing

In 2023, RCPH provided 27 bacteria/nitrate well water test kits to residents.

DNR Childcare Lead-in-Water Testing Program

In 2023, RCPH sampled 12 facilities. 4 of those tests came back with at least 1 high sample. 2 facilities are currently being remediated.

In total, 196 samples were taken and 22 came back with high levels of lead.

Beach Water Monitoring

Beaches monitored in the RCPH jurisdiction include Bohners Lake (Aukes, Leach and Public Beaches), Fischer Park Beach, North Bay Parkway Beach, Quarry Lake Park Beach, and Wind Point Lighthouse Beach.

RCPH posted 4 Caution and 1 Closed sign throughout the 2023 beach season.

<u>Home Visiting</u>

Hello Baby Universal Home Visiting

In 2023, RCPH introduced Hello Baby Racine County, a program that provides a nurse home visit for all parents of newborns in the community.

RCPH developed new marketing materials and a new website (including a virtual resource library) to better serve our community.





Partnerships with UW-Milwaukee and Walworth County Public Health

- developed new screening, referral, and nurse protocols
- trained nurses on the new protocol, interview techniques, and implementation
- continue to provide training and support as needed

Implementation in neighboring counties provides an opportunity for recruitment of residents who gave birth outside of Racine County.

Healthy Families America (HFA) Model Home Visiting Programs

For the 2022-2023 grant cycle, RCPH provided 1124 home visits for 92 families.





Emergency Preparedness




Emergency Preparedness

Emergency Preparedness facilitates organizational and community resilience in the face of a wide range of hazards. Health department staff, in cooperation with other county departments and partners, continue to develop emergency response plans and protocols, and identify internal and external resources that can be deployed by the Health Department during a public health or other emergency.

2023 Budget Summary

The 2023 levy contribution was \$10.99 per capita, significantly less than the national average of \$18 per capita for local health departments.

Of note, Wisconsin ranks in the bottom quartile for public health expenditures relative to the rest of the country.
