AWARD OF EXCELLENCE

Central Racine County Health Department is announcing the winners of its 2018-2019 Award of Excellence for food facilities. For the third year, Central Racine County Health Department is acknowledging food facilities that regularly meet a high standard of food safety by issuing an annual award to these facilities. This award is supported by our local food industry committee members as well as the Central Racine County Board of Health.

Facilities that qualify are licensed as a *moderate complexity restaurant, high complexity restaurant, large potentially hazardous food retail store or small potentially hazardous food retail store.*

Examples of facilities that may qualify are:

- Fast Food Restaurants
- Sit-Down Restaurants
- Restaurants with Banquet Facilities
- Restaurants with Buffets or Salad Bars
- Large Grocery Stores
- Large Convenience Stores
- Ice Cream Shops
- Bakeries
- Coffee Shops
- Take and Bake Pizza Stores

The criteria for the award are:

- No major (Priority¹) violations for two consecutive years of inspections.
- No moderate (Priority foundation¹) violations for one year of inspections.
- No more than six minor (Core¹) violations on average per year for two years.
- No confirmed foodborne illnesses associated with the facility in the past five years.
- No ongoing issues as identified by the Environmental Health Director.

The following are examples of the different categories of violations:

Priority Violations

- Food employees not washing their hands when they should be.
- Food not cooked to proper temperatures.
- Food not stored at proper temperatures.
- Ill food employees working with the food.
- Cooked foods not cooled properly.

Priority Foundation Violations

- An accurate food thermometer is not present.
- Foods are not properly date marked.
- Records for fish and shellfish that are served raw or undercooked are not maintained.
- Customer self-service areas are not monitored by employees.
- Food employees are not washing their hands in the proper sinks.

Core Violations

- Floors, walls, ceilings and equipment are not clean.
- Floors, walls, ceilings and equipment are not maintained.

Certificates are issued after the end of the license year and state that the award was for the previous license year. For example, an award issued in August 2019 lists the license year 2018-2019.

Facilities that meet the criteria for the award receive a certificate they can post at their facility. Additionally, the list of facilities receiving the award are posted on our website and social media sites.
