RACINE COUNTY COVID-19 UPDATE **August 3, 2020**

Confirmed coronavirus cases

United States: 4,690,404 confirmed, 155,124 deaths

Wisconsin: 55,328 confirmed, 911,435 negative, 949 deaths

Central Racine County Health Department: 1,369 confirmed (+192 from last week), 180 probable (+4), 21,283 negative (+1,906), 45 deaths (+3)

City of Racine Health Department: 1,932 confirmed (+135 from last week), 224 probable (+12), 18,093 negative (+1,729), 31 deaths (+1)

Racine County total: 3,301 confirmed (+327 from last week), 404 probable (+16), 39,376 negative (+3,365), 76 deaths (+4)

Updates for the week of August 3:

- Governor Evers has issued an Executive Order declaring a Public Health Emergency and requiring facemasks statewide.
 - Additional Q&A About Cloth Face Covering
- Details have changed for the community drive-thru testing site to be conducted by the Wisconsin National Guard this week at Festival Hall. The site will now operate Tuesday, August 4, and Wednesday, August 5, at 10 a.m. to 6 p.m. The maximum total number of tests administered will be 1,000.
- The National Guard administered 1,593 COVID-19 tests at the testing site last week at Case High School.
- Beginning Monday, Aug. 3, the Wisconsin Department of Health Services is launching a COVID-19 Test Result Hotline for individuals tested at National Guard testing sites in Wisconsin. If you've been waiting more than five days for your results, or if you need a copy of your results, call the Wisconsin COVID-19 Results Line at (866) 419-6988. The COVID-19 Results Line is open Monday-Friday from 8 AM – 6 PM. The Results Line only provides test results for COVID-19 testing performed at National Guard testing sites in Wisconsin. Upon calling, you will need to provide the date of your test, the National Guard testing site you visited, your name, and your date of birth. Residents are asked to wait to call the results line until 5 days after your test. Results can also be mailed.
