If you have been operating without a license, you will be required to pay a surcharge in addition to the license fee. Licenses are not transferable between persons or locations. Licenses expire annually on June 30. The license fee is *not* prorated for partial license years. The Department may inspect premises at any reasonable time. Missing information may delay the issuance of your license.
